

Nevertheless workers have continued to exhibit resilience in overcoming these challenges to provide for their families and meaningfully contribute to the economic development of Uganda. PLA pledges to continue to be at the forefront in ensuring decent work for all vulnerable and marginalized workers including access to justice, social protection and responsive legal and policy framework within the labour and employment sector.

#### DOMESTIC WORKERS PETITION SPEAKER OF PARLIAMENT

PLA supported Domestic workers through their umbrella body Domestic Workers Association (DOWA) to develop a petition paper which they presented to the speaker of parliament to expedite the passing of the Employment Amendment Bill 2019. The Speaker in response promised to pass the Bill.


# Parliament Passed the Employment Amendment Bill 2019

Following the domestic workers petition to the speaker, on 1st April 2021 the parliament of Uganda discussed and passed the Employment Amendment Bill 2019. The Bill seeks to protect and recognize vulnerable groups of workers such as the domestic workers, casual workers and breast feeding working mothers.

This quarter, 815(275 female, 540 male), poor vulnerable and marginalized persons received free legal aid services across our districts of operations. Our clients came from different sectors of employment including construction workers, security guards, driver's food vendors, farmers, Hair dressers, boda boda cyclists and business persons.

Overall, the nature of claims reported varied from nonpayment, unfair termination, workers compensation, un lawful dedications, trafficking in persons, failure to remit NSSF by employers while the eastern and northern districts reported more cases on land matters, child neglect and domestic violence. ### 96 CLIENTS RECOVERED THEIR DUES

- 96(37 female and 59 male) clients recovered their owed dues from employers totaling to Ugx. 72,886,833/= (Seventy Two Million Eight Hundred Eight six Thousand Eight Hundred thirty three Shilling only). The money recovered was unpaid wages, loan repayments, NSSF savings, medical facilitation, workers' compensation and compensation for unfair termination and dismissals.
- For many of the workers the money recovered is used to pay off debts, carter for medical expenses for the families, send financial assistance to relatives in the villages, start up for small businesses

was recovered for and on behalf of 96 clients (59 male, 37 female).

# 64 police suspects released on police bond



Represented, supported and enabled 64 police suspects at Kaliro, Bugir, Dokolo, Amolatar central police stations to be released on police bond. This would enable them to prepare adequately for their cases as well as enabling them to provide for their families

## 3,556, Workers and Employers Receive Awareness Messages


